The recommendations were then approved by the Leadership Board at their June meeting, as part of the Leadership Board's strategic direction to the NOFO Committee. 3. The NOFO Committee is now tasked with figuring out how to implement the recommendations when they adopt the policies, scoring factors and application forms for the local competition. 4. Katricea Stewart, Homebase, shared a memo summarizing recent steps to support the Persons with Lived Experience (PWLE) who are engaged in Continuum of Care (CoC) activities through a multi-step feedback process. The memo included the steps of collecting feedback, a summary of the feedback received, and the next steps.</p> <p>b. <p>7. Youth Advisory Board (YAB) Retention, Recruitment, Outreach (RRO) Committee Overview of Youth-Servicing and Transition Age Youth (TAY) Programs/Resource Guide</p> <p>a. Background:</p> <p>i. Progress towards CoC Youth Committee Goal: “To design, implement, and operate collaborative processes for parallel systems working with TAY experiencing homelessness.”</p> <p>ii. Landscape of Youth/TAY Targeted Services: (1) level-set on existing youth/TAY services in the county, and (2) level-set which services are intentionally engaging youth/TAY</p> <p>b. Findings:</p> <p>i. Surveys are the most common youth engagement effort, especially for housing and education resources – least effort and funding needed.</p> <p>ii. Youth internships and employment are most common for employment/workforce development and disability justice</p>	4:00-4:25



<ul style="list-style-type: none"> iii. Paid (stipend) focus groups are most common for behavioral health services. iv. Youth advisory boards are integrated in many housing and civic engagement services. v. Funding information was challenging to find because it is not often publicized and many phone call representatives were unaware. Funding information was more so found through internal connections. <p>c. The Committee members reviewed and discussed the TAY Engagement Opportunities chart.</p>
