Meeting Purpose / Overview

Today's meeting brings the HMIS Committee together to review ongoing work to strengthen Alameda County's HMIS governance, data quality, and overall system capacity, and to discuss potential adjustments to the committee's structure and operations. We will hear updates on technical assistance efforts, including the development of an HMIS Roles and Responsibilities Matrix and Data Flows Chart, explore ideas such as shifting to bi-monthly meetings and launching quarterly HMIS Office Hours, and consider the Leadership Board's request to assess potential committee consolidation with the System Impact Committee. This discussion will help

clarify priorities, ensure the committee's work remains focused and impactful, and guide next steps in supporting effective HMIS administration for the CoC.

2. Approval of Minutes (Co-chairs)	9:02 - 9:03

5. **Strengthening Data Capacity and HMIS Governance in Alameda County (**Melissa Mikel, Grant Tuioti, ICF and Alex Baker, HMIS Lead Team)

9:08 - 9:30

The HMIS Lead Team and ICF will share updates on recent technical assistance efforts to enhance Alameda County's HMIS and data infrastructure. The presentation will cover new tools, including a Roles and Responsibilities Matrix and HMIS Data Flows Chart, and outline how these resources support clearer governance, stronger data quality, and more effective system-wide data use.

Notes:

- Members expressed appreciation for the new roles/responsibilities matrix and flow chart clarifying accountability and data flows.
- A committee member raised that while the visuals show back-end processes, they do
 not capture whether individuals actually receive outcomes or support. He emphasized
 the need to ensure that Black and Brown men, veterans, and others who enter HMIS
 but do not receive help are visible in reporting.
- This led to discussion about where outcomes for individuals appear (e.g., APR, LSA, HUD reports). Staff explained these reports allow tracking of exits and outcomes, but acknowledged gaps in ensuring follow-up and accountability.
- Folks discussed the need for a stronger system-level follow-through and a reminder that the tools must ultimately serve the person with lived experience.
- Members requested that the visuals be shared widely as a community reference tool.

6. Quarterly Data Quality Report - Report Out (HMIS Lead)

9:30-10:00

Quarterly Data Quality and Occupancy Report

Notes:

- Discussion focused heavily on timeliness, completeness, and overlapping enrollments.
- A committee member asked how timeliness is calculated (e.g., if data entry happens after a Friday intake). Staff clarified HUD's standard is business days but committed to verifying how Clarity tracks. Best practice discussed: enter data before leaving for the day to avoid delays.
- A committee member questioned whether overlapping enrollments referred only to housing. HMIS staff clarified it includes all program enrollments (often duplicate entries due to start/end date changes). Committee member suggested reviewing overlapping data more frequently (monthly/quarterly), not only during LSA.
- There was discussion of utilization rates (beds/capacity). Members noted high utilization is positive but wanted it pushed even higher.
- A committee member asked how benchmarks are set; staff confirmed they are based on HUD standards, with slightly higher internal targets. When goals aren't met, the HMIS team develops follow-up plans with agencies.

 Committee members will discuss potential adjustments to the HMIS Committee's structure and operations as part of a broader CoC-wide review of committees. Topics will include ideas to strengthen the committee's focus, such as shifting to bi-monthly meetings and introducing quarterly HMIS Office Hours, as well as the Leadership Board's request to explore a potential merger with the System Impact Committee.

Notes:

- Discussion centered on the proposal to merge the HMIS Committee with the Systems Impact Committee into a broader Data Committee.
- Members generally supported bi-monthly meetings and quarterly structured HMIS office hours to reduce duplication, prepare more meaningful agendas, and provide space for Q&A. Multiple members stressed that office hours need to be intentional and structured, not casual drop-ins, with questions submitted in advance.
- Committee members welcomed consolidation as a way to streamline and improve efficiency.
- Members agreed that office hours could also serve as prep or deeper-dive sessions (e.g., reviewing acronyms, data definitions, or exploring recurring issues like outreach exits).
- Broader input suggested the restructure could increase participation, reduce duplication, and create stronger alignment between HMIS operations and system outcome analysis.
- Homebase staff clarified that no decision is final; any governance change would be brought to the October community meeting for a full vote.
