## 7. HMIS Client Facing Portal (H&H)

The HMIS Lead Team will provide an overview of the planned HMIS client facing portal.

#### Minutes:

The HMIS lead provided updates on the HMIS client-facing portal, which is a web-based platform designed to give clients access to their own information within HMIS. The portal's goal is to allow clients to update information such as address or phone number and enable direct communication with their providers for questions or updates. This feature is expected to help address issues like transportation difficulties or lost cell phones. Other functionalities include a calendar, active client history, document section, privacy settings for ROIs, a referral section for new programs, and an assessment area where providers can request clients to complete specific assessments. Additionally, clients can choose to share their location, and providers can request location updates, which is seen as a significant benefit for outreach workers trying to find individuals, especially with frequent encampment sweeps. A resource directory and a community info article section will also be available, allowing agency staff to update relevant resources and share informational articles with clients. The portal is slated for a phased rollout starting in October, beginning with some youth providers, and then expanding quarterly to the broader community. Training for agency providers and consumers will be part of the rollout, with support times and FAQs available on the website. The HMIS team, including Alex, was thanked for their work on this initiative.

#### 8. ACTION ITEM: Vote on Encampment Resolution Guide

In August the Unsheltered Workgroup provided an overview of the work completed on the CoC Encampment Resolution Guide. The document will be put for a vote to be adopted and submitted to the Evidence Based Solutions Committee for review.

#### Minutes:

The committee voted on the CoC Encampment Resolution Guide, which had been included in meeting materials and discussed previously. During the discussion, Committee members expressed reservations about including a CoC leadership representative on the core strategy team, stating it was logistically impossible for every encampment resolution and didn't align with the CoC's approach in Alameda County. Members recommended removing the entire paragraph related to this, especially the part that suggested one person could set coordinated entry policy, which they found alarming regarding equity.

Amy Cole Bloom made a motion to adopt the guide with the amendment to remove the section on page 15 that includes a CoC representative in the core strategy team. Jenn seconded the motion.



The motion passed with 9 "yes" votes and 1 abstention. The guide will be presented to the Evidence-Based Solutions Committee (ESC) on October 9th from 11 AM to 1 PM, and a representative from the committee or the unsheltered workgroup is needed to present the document

#### 9. Update on GBV trainings (H&H)

H&H will provide an update on Gender Based Violence provider trainings.

#### **Minutes**

Alan provided an update on the gender-based violence training, which is an initiative planned to start in 2026 as part of bringing the gender-based violence coordinated entry system online. The training will focus on best practices for serving survivors of gender-based violence and will involve partnerships with Alameda County organizations. The group was invited to share areas of interest for the training. Members suggested training on safety protocols and privacy for staff in shelter settings, particularly regarding entering information into HMIS for survivors, and bridging understanding for general providers on how to partner with specific GBV providers. She also mentioned protections for people in permanent housing needing VAWA or gender-based violence transfers and how to advocate for these with housing authorities. There was a question about the process for survivors accessing coordinated entry through the "DV way". Alan explained that three new brick-and-mortar access points are opening for survivors of gender-based violence, in partnership with SAVE, the Family Violence Law Center, and Building Futures. Survivors can also use existing non-specific access points. Kate Hart clarified that while there isn't dedicated emergency shelter directly funded by Housing & Homelessness Services within the GBV coordinated entry system, the existing DV and GBV system in Alameda County has historical methods for connecting survivors to emergency resources. She described her agency's plan for access point services, which include walk-in assessments and simultaneous emergency assessments to connect individuals to available shelter resources. There was a question about balancing support for an accuser with ensuring a fair opportunity for the accused in Gender Based Violence cases within shelter settings, asking about due process before termination. Kate noted her agency does not shelter intact couples and focuses on victimized individuals, referring those causing harm to other resources. Alan acknowledged this as an important point for future training to include information on connecting people who've caused harm to resources.

#### 10. Planning for Community Meeting

The Committee will discuss and develop key updates to share at the May 6 Community Meeting at the California Endowment. The group will also identify a committee member to present these updates at the meeting.

#### Minutes:

The committee discussed what accomplishments and updates to highlight at the upcoming community meeting, scheduled for Tuesday, November 18th at the California Endowment. Proposed highlights included:

- The approval of Coordinated Entry policies and procedures in May, and their evolution to include the gender-based violence Coordinated Entry System.
- The recently passed CoC Encampment Resolution Guide.
- Jenn wanted to highlight Matt and Jose's work with the OAC.
- Alan wanted to highlight the work that Kate Hart, Anna Fellers, Suzanne Campillo, Danielle Driver Bellino, Alex Baker, and the full HMIS team have put into the gender-based violence coordinated entry process.



Courtney inquired if the Coordinated Entry Evaluation would be finished anytime soon.
Homebase indicated they hope it is ready by the October committee meeting. Feedback
