Litigation Update

- In response to a court order issued December 23, 2025, HUD has withdrawn the FY 2025 NOFO and re-issued the two-year 2024-2025 NOFO (originally released in July 2024).
- The NOFO opened January 9 and will close on February 9, 2026, with awards to be made no later than March 2026.
- HUD is proceeding to process requests for renewal of all eligible projects, as per the terms of the two-year NOFO.

Litigation Update

- HUD has made clear that if the court order is no longer in effect, they will move to implement the 2025 NOFO issued in December.
- The court case is proceeding to final judgement on an expedited basis.

Implications for Grantees - Renewals

- All current grant recipients may request renewal of their grant.
- Grantees that received an award in FY 2024 can request renewal through a process that HUD has not yet specified.
- Grantees that did NOT receive an award in FY 2024 must submit a Project Application in E-SNAPS. This only applies to 5 grants (all are recipients of SNOFO funding, which were awarded 3-year grants in 2022).
- Renewal grants are not subject to any of HUD's new requirements relating to Executive Orders and new policy priorities; they are governed by the 2024-2025 NOFO.

Communications with Current Recipients

- The Collaborative Applicant has:
 - Reached out to all current grant recipients with updates on how to submit renewals.
 - Encouraged all current grant recipients to request renewal, so that we can have another year of funding stability while developing strategies to prepare for the FY 2026 NOFO.
 - Requested current recipients to let us know if they are NOT planning to renew their grant.

Implications for Applicants – New Projects

- The re-issued 2024-2025 NOFO does not include any options for requesting new projects through bonus funding.
- If any current recipients choose not to renew their grant, those funds can be re-allocated to create new projects.
- New projects may be: Permanent Supportive Housing (PSH), Rapid Rehousing (RRH), Joint Transitional Housing/Rapid Rehousing (TH-RRH), Coordinated Entry (SSO-CE), or Homeless Management Information System (HMIS) projects.

Status of E-SNAPS and HUD Instructions

- E-SNAPS is open for Applicants to set up Project Applications
- Instructions have not been issued, and the Project Priority Listing is not yet available.
- Questions not yet answered by HUD:
 - How projects request renewal outside of E-SNAPS.
 - Whether any projects must be scored and ranked.
 - What local process, if any, must be followed to submit a re-allocation project.

Possible Actions Needed by February 9

- Develop and approve a process to score and/or rank renewing projects.
- Develop and approve a process to solicit/select new project(s) created through re-allocation. This will only be applicable if any current recipients choose not to renew.
