Announcements</p> <p>Homelessness Prevention Program Dashboards:</p> <p>The Housing Stability and Homelessness Prevention (HSHP) Committee has created dashboards of Homelessness Prevention Programs in Alameda County.</p> <p>There are two dashboards:</p> <ul style="list-style-type: none"> • Homelessness Prevention Landscape Dashboard: A dashboard focused on the landscape of prevention programs in Alameda County, including how they are funded. System leaders and funders who will use this dashboard when making decisions about policy, funding, etc. • Homelessness Prevention Resource Guide Dashboard: A dashboard for community members and service providers who will use the program information to identify resources that will help households to prevent homelessness. <p>The dashboards are available on the HSHP Committee page on the EveryOne Home website.</p> <p>New resource: Homebase staffing for 2026: As we look to the new year we wanted to give an updated staffing directory! <p>Minutes:</p> <ul style="list-style-type: none"> • Two new dashboards (Landscape and Resource Guide) are now live on the Everyone Home website to help system leaders and community members identify prevention resources. • New resources were announced, including an updated Homebase staffing directory and an ACOC membership roster with contact information for voting members. • Took a “pulse check” in the chat regarding changing the SIC meeting time to the third Wednesday of every month from 9:00 AM to 11:00 AM to better alternate with HMIS committee meetings.

<p>6. 2025 SIC Work Plan Workstreams</p> <p>Discussion: Report Cards</p> <ul style="list-style-type: none"> • The HMIS team will present APRs (Annual Performance Reports) to help our committee identify any potential data points we would be interested in monitoring in provider report cards. <p>Minutes:</p> <ul style="list-style-type: none"> • APR Presentation originally scheduled for today was moved to the next meeting due to a scheduling conflict <p>Discussion: 2026 Work Planning – voted yes on work plan</p> <ul style="list-style-type: none"> • As we kick off 2026, we would like to hear what the committee would be interested in focusing on for the next calendar year. Committee members are welcome to present ideas or areas of focus for the group to discuss. We will be reviewing the current version of the work plan <p>Minutes:</p> <ul style="list-style-type: none"> • Nic emphasized the need to streamline the work plan with the HMIS committee, particularly regarding how data quality informs provider performance reviews. • Zae raised concerns that the current feedback loops for people with lived experience are too small (e.g., interviewing 60 people to represent 4,000). The committee discussed drafting guidance to ensure research includes a representative number of participants. 	<p>3:25 – 4:00</p>

- Jared raised the question of how the committee can assist other organizations in getting involved in system work rather than being excluded for various reasons at the city level or otherwise. Fiani echoed Jared’s points, expressing concern about how larger organizations may control the dynamics of the space while smaller organizations that support unhoused individuals in humane ways might not receive the same support. Also suggested looking into mechanisms like funding cuts for organizations that do not support the unhoused in a humane manner.
- It was suggested that the committee could bring forward the dashboards David is working on to help members better understand and use the data currently in practice.
- Josh highlighted the need to use data to identify both high and low-performing programs. He emphasized using this data to build internal capacity within programs on specific topics to improve overall system performance.
- There was a motion to approve the 2026 workplan and it was approved with 6 yes votes.
